### Board of Trustees of Northern Illinois University Research and Innovation, Legal and Legislative Affairs Committee Meeting

May 9, 2024

#### CALL TO ORDER AND ROLL CALL

The meeting was called to order at 10:30 a.m. by Committee Vice Chair Rita Athas. Recording Secretary Rachel Jurs-Lauderdale conducted a roll call of the Trustees.

#### VERIFICATION OF QUORUM AND APPROPRIATE NOTICE OF PUBLIC MEETING

General Counsel Bryan Perry indicated the appropriate notification of the meeting had been provided pursuant to the Illinois Open Meetings Act. Mr. Perry also advised that a quorum was present.

#### **MEETING AGENDA APPROVAL**

Committee Vice Chair Athas asked for a motion to approve the meeting agenda. Trustee Strom so moved, and Trustee Moore seconded. The motion was approved.

#### **REVIEW AND APPROVAL OF MINUTES OF FEBRUARY 15, 2024**

Committee Vice Chair Athas asked for a motion to approve the minutes of February 15, 2024. Trustee Wasowicz so moved, and Trustee Barsema seconded. The motion was approved.

#### CHAIR'S COMMENTS/ANNOUNCEMENTS

Committee Vice Chair Athas welcomed University Advisory Committee Members and opened the floor to remarks. Committee Member Bradrick Cripe extended acknowledgment and appreciation to Dr. Harris for her work in bringing in Research and Innovation funds for the university and for faculty to use. Committee Vice Chair Athas welcomed all other members and shared appreciation for Dara Little and the work her office is doing along with her amazement at the continued trend of increased funding from state and federal sources. She noted that VP Harris will highlight information about the work happening in the College of Engineering and Engineering Technology. Committee Vice Chair Athas points to the awards and recognition we will hear about and notes the importance of NIU developing the pipeline and research from both faculty and students.

#### **PUBLIC COMMENT**

Committee Vice Chair Athas introduced the public comment portion of the meeting. General Counsel Bryan Perry confirmed that no public comments were received.

#### UNIVERSITY REPORTS

Committee Vice Chair Athas asked Vice President for Research and Innovation Partnerships Yvonne Harris, to provide an update from the Division of Research and Innovation Partnerships.

Vice President Harris acknowledged another strong quarter of research funding noting that growth is steady with 47 sponsored awards, totaling \$7.2M. Compared to the same period last year, research funding increased by 17%, instructional funding increased by 17%. Projections suggest that NIU remains on target to meet or exceed FY23 federal and state sources of sponsored funding levels of \$61M.

Vice President Harris mentioned that NIU faculty continues to be recognized for its excellence in research and teaching and shared that NIU Assistant Professor Jifu Tan, from the College of Engineering and Engineering Technology, recently received the CAREER grant for his work studying blood clotting.

Vice President Harris also recognized Assistant Professor of Geology, Dr. Suzanne Autry-Mulligan, whose work focuses on the relationship between rock formation and the ages of the Grand Canyon landscape.

Vice President Harris also recognized Katie Erdmann and Federico Bassetti for launching Girls Who Code at NIU, in the 71 North Partnership Studio. Since the launch event, the chapter has grown to over 40 members in just a few weeks.

Vice President Harris continued with recognition by acknowledging student entrepreneurs Katie Erdmann and Nikhil Doddaga for placing second in the De La Vega pitch competition. Nikhil a finalist in the 1871 Tech Challenge 2024, started a student organization Huskie Hackers for coders to participate in National Hackathons.

#### Agenda Item 7.a. – State Legislative Report

Katie Davison was unable to attend, and Dr. Matt Streb stepped in to give the written report. Committee Vice Chair Athas opened the floor for questions and comments. There were no questions or comments from the Board.

#### Agenda Item 7.b. Federal Relations Report

Ms. Julia Rowe joined virtually to present updates to the Federal Relations Report. Committee Vice Chair Athas opened the floor for questions and comments. Trustee Barsema asked in terms of FAFSA, has there been any discussion of any relief funding for universities that have been affected by it. Ms. Rowe responded there has not been any discussion of funding. Committee Vice Chair Athas asked if there has been discussion at the federal level to ensure that the issues with FAFSA are not reoccurring. Ms. Rowe responded there has been discussion to resolve the issue moving forward. Committee Vice Chair Athas continued, have there been any request for student testimony, and Ms. Rowe answered there has not. Committee Vice Chair Athas asked Vice President Harris and President Freeman how the cut to the National Science Foundation budget will impact us. Vice President Harris responded further conversations need to be had, and the impact going forward is unknown at this time. President Freeman added that other than the

Department of Energy, the Nation Science Foundation is a major funder of our faculty and graduate students and a cut is never something NIU wants to see, as that will make competition for dollars harder.

#### Agenda Item 7.c. Sponsored Programs Administration Quarterly Report

The Committee reviewed the sponsored programs administration quarterly written report submitted by Ms. Dara Little, Associate Vice President for Research/Executive Director Sponsored Programs.

#### Agenda Item 7.d. – Northern Illinois University Faculty Presentation

Dr. David Gunkel gave a verbal presentation on AI. Dr. Gunkel stated he wanted to talk about generative AI in general, however that topic is too broad. The presentation focused on large language models.

#### **OTHER MATTERS**

Committee Vice Chair Athas asked if there were other matters to come before the Committee. Trustee Wasowicz shared a thought about Vice President Harris' comments at the start of the meeting and thanked her for highlighting the accomplishments that are being made. The Committee confirmed that there were no other matters to be discussed.

Committee Vice Chair Athas noted that the next meeting will be held on August 22, 2024.

#### STATE LEGISLATIVE REPORT

This report covers the period from May 2024 to July 2024.

#### **2024 Legislative Session Recap**

On May 29, 2024, the General Assembly approved the 2025 fiscal year budget, closely mirroring the Governor's proposed budget for higher education, with a few unexpected additions.

NIU received a \$100,621,300 appropriation for operating expenses, marking a 2% increase from the previous fiscal year. All capital projects, capital renewal, and capital improvement funding authorized under the Rebuild Illinois Capital Program were reappropriated in the 2025 fiscal year budget. An additional \$450M was allocated to the Illinois Board of Higher Education (IBHE) for unspecified deferred maintenance projects at four-year universities. This funding resulted from the universities' persistent advocacy to address critical maintenance needs and safety enhancements.

The budget includes \$711,566,200 for Monetary Award Program (MAP) Grants, an increase of \$10M from fiscal year 2024. The AIM HIGH program appropriation remains level with the previous year's funding at \$50M for the 2025 fiscal year.

The Mental Health Early Action on Campus Act line item sees an increase of \$2,382,900, bringing statewide funding to \$7M to aid universities in addressing the mental health challenges faced by students. Additionally, a new appropriation of \$6M is included for Illinois Veterans' Grants and Illinois National Guard Grants.

#### **Substantive Higher Education Bills**

#### SB3594 - ILLINOIS ARTICULATION INITIATIVE

- Sponsors: Sen. Cristina Castro; Rep. Katie Stuart
- **Summary:** Amends the Illinois Articulation Initiative Act to ensure public institutions without equivalent major or lower-division courses compliant with major panel descriptors and course approval criteria are considered compliant for that academic year. Effective immediately.
- Status: Passed Both Houses on 5/23/2024 awaiting Governor's signature

#### **HB3760 - HIGHER ED-UNIFORM ADMISSION**

- Sponsors: Rep. Katie Stuart; Sen. Paul Faraci
- **Summary:** Amends the Public University Uniform Admission Pilot Program Act to create a four-year uniform admission system pilot program for community college transfer students starting with the 2024-2025 academic year. Exempts universities with existing policies equal to or less restrictive than those prescribed in the Act.
- Status: Public Act 103-0205 on 6/30/2023.

#### **Commission on Equitable Public University Funding**

NIU continues to engage with legislators and advocates as they develop legislation for a new equity-based funding model for higher education in Illinois. The Commission on Equitable Public

University Funding chairs have organized the release of a bill directing funding to public universities, scheduled for July 31 in Chicago. Following the release, a press conference and roundtable discussion will be held to discuss the bill's implications and details. NIU will participate in the event, providing input and feedback throughout the process.

#### **Veto Session**

The veto session is scheduled for November 12 - 14 and November 19 - 21. NIU will monitor impactful legislation and engage with legislators and advocates on important issues.

#### **Spring Session Planning**

During upcoming legislative sessions, the Office of State Relations will prioritize addressing the university's budget deficit and the historical underfunding of higher education. Efforts will focus on advocating for increased state funding, identifying alternative State funding sources, and raising awareness of the implications of past underfunding of higher education in Illinois. Strategies include legislative engagement, policy proposals, collaboration with federal relations, and organizing advocacy events. Additionally, emphasis will be placed on building coalitions and partnerships, engaging with the NIU Caucus, and mobilizing the NIU community to support advocacy efforts.

#### FEDERAL RELATIONS REPORT

This report covers the period from May to July 22<sup>nd</sup>, 2024.

#### **Congressional Update**

On June 11<sup>th</sup>, President Freeman was in Washington, D.C. and met with Reps. Jonathan Jackson (IL-1), Robin Kelly (IL-2), Sean Casten (IL-6), and Nikki Budzinski (IL13), to discuss NIU's FY25 appropriations requests and legislative priorities.

On July 18<sup>th</sup>, Rep. Lauren Underwood and her district and Washington, D.C. based staff were on campus to tour federally funded programs and student resource centers.

#### **Appropriations Update**

The House Appropriations Committee has passed all 12 appropriations bills out committee and 5 have passed out of the House. The Labor, Health and Human Services, and Education (Labor-HHS) subcommittee allocation is cut 11% compared to FY24 levels. The bill includes cuts of 50% to Supplemental Educational Opportunity Grants (SEOG) and Federal Work Study (FWS). The bill would again flat-fund the maximum Pell Grant at \$7,395. The bill further cuts the Institute of Education Sciences, 7%, and zeroes out the Graduate Assistance in Areas of National Need (GAANN) and Child Care Access Means Parents in Schools (CCAMPIS) programs.

The House Commerce-Justice Science bill includes a 2% cut to the National Science Foundation.

The Senate continues to work through a bipartisan process for their appropriations bills and has moved three bills out of the Committee.

#### **Legislative Update**

<u>NDAA</u>: The House has advanced their National Defense Authorization Act of 2025, the amendments of concern for NIU including the inclusion of the DETERRENT Act and Bipartisan Workforce Pell Act were not made in order for floor consideration. The Senate Armed Services Committee is working on the Senate's version, which includes some provisions of concern related to research awards, limitations on international collaboration and prohibitions on institutions who have violated Title VI of the Civil Rights Act. Floor time to advance the bill has not yet been announced.

<u>FASFA</u>: The House Education and Workforce Committee marked up H.R. 8932, the FASFA Deadline Act, which would move the statutory deadline for the Department of Education to make the FASFA available from January 1 of the applicant's enrollment year to October 1 of the year before. Floor consolidation of the bill has not yet been accounted. The six presidential higher education associations have endorsed the legislation.

#### **Biden Administration and Agency Update**

<u>FASFA</u>: To minimize disruptions for students, families and institutions, the Department of Education announced that the 2025-26 FAFSA will remain consistent with the 2024-25 form. The Department has worked to address and resolve all major known issues with the 2024-25 form and will continue to make improvements to the form.

<u>DACA</u>: On June 18<sup>th</sup> the White House announced several changes to the DACA program, including allowing noncitizen spouses and children to apply for lawful permanent residence status, and easing the visa process for U.S. college graduates.

#### **Courts Update**

On June 14<sup>th</sup> the Chief Judge of the Eastern District of Louisiana ordered a preliminary injunction on the Biden Administration's Title IX rule applying to Louisiana, Montana, Mississippi, and Idaho. On June 17<sup>th</sup> the Chief Judge for the Eastern District of Kentucky issued an injunction on the Title IX rule within the six plaintiff states of Tennessee, Kentucky, Ohio, Indiana, Virginia, and West Virginia. In another separate matter, a federal court in Texas struck down the Biden administration's guidance on the application of Title IX to sexual orientation and gender identity. There are at least seven lawsuits seeking to block the rule. The rule goes into effect on August 1<sup>st</sup> in the states not impacted by the injunctions.

### SPONSORED PROGRAMS ADMINISTRATION QUARTERLY REPORT

This report provides information for externally funded awards received by Northern Illinois University for Fiscal Year 2024. For FY24, NIU secured 370 awards that totaled \$56M and were distributed as follows: \$18M for research, \$9.4M for instruction, and \$28.7M for other sponsored activities (OSA) (Figure 1). The 9% overall decline in total funding from FY23 to FY24 is primarily attributed to the conclusion of COVID-19 funding<sup>1</sup> and adjustments to SPA reporting to amortizing multi-year awards. Despite the overall reduction, research continues to show signs of growth with an increase of 11% over last year and 40% in the past five years. Excluding the short-term infusion of COVID-19 money, total sponsored funding increased 53% since FY20 and held relatively steady to last year (Figure 2).





Federally funded support saw a decrease of 7%, while State of Illinois funding declined by 13% (Figure 3). Awards from Public/Not-for-Profit sources experienced a reduction of 31%. In contrast, corporate funding increased 34%. Support from foreign sources remained unchanged accounting for <1% of the overall funding portfolio. As federal and state funding accounts for most of NIU's sponsored funding portfolio, the decline in overall funding aligns with the decline in support from these sources. The increase in corporate funding is due to programs managed in the College of Business and discussed below.



#### **Top Funders by Program Type for FY24 Quarter 4**




Figure 4 Note: Other category includes agencies contributing 1% of the total. Amounts based on originating fund source.

The main contributors for Organized Research funding in the fourth quarter included the Illinois Department of Public Health, the National Science Foundation, and the Department of Energy (Figure 4).

The Illinois Department of Public Health awarded a tenyear contract to faculty in the School of Interdisciplinary Health Professions to coordinate a national behavioral health risk factor survey from a

scientifically drawn sample of adults throughout Illinois. The total value of this contract over the ten-year period is \$17M; however, to smooth reporting trends SPA will report each budget period on an annual basis.

Faculty in the departments of Biological Sciences and Chemistry and Biochemistry secured research funding from the National Science Foundation. In Chemistry and Biochemistry Dr. Tao Li secured new and continuing grant support from the agency totaling \$715K for three projects including: testing a proposed concept for lower-cost, CO2-free hydraulic fracturing for the energy industry, which could have major industrial applications and play a pivotal role in ensuring a clean, secure, and affordable energy future; designing the next generation of liquid electrolytes for high-voltage alkali-metal batteries by understanding the fundamental interactions between ions and solvents; and studying molten salt nanoparticle synthesis using combined small-angle X-ray scattering and X-ray absorption spectroscopy at Advanced Photon Source. In Biological Sciences, Dr. Heather Bergen-Roller won a \$384K award to support a postdoctoral fellowship with the aim of fostering well-being and academic success in biology undergraduate students.

Department of Energy funding encompassed several awards this quarter with support directly from the agency as well as through Argonne National Laboratory and Fermilab. Funding from Argonne supported projects across university departments including Chemistry and Biochemistry, Physics, and Mechanical Engineering with most of the funding (\$233k) to the Department of Physics. These agreements provide stipends for graduate research assistants training under NIU and lab researchers on various research methods and instrumentation techniques, and faculty joint appointments. One contract from Fermilab valued at \$219K to the Department of Physics funded a scientist to support NIU research in beam dynamic studies. Direct funding from the Department

of Energy supported several continuing research projects, also in the Department of Physics, ranging from particle physics to large scale international research experiments.




Figure 5 Note: Other category includes agencies contributing less than 1% of the total.

Figure 5 illustrates the distribution of funding for Instructional **Programs** received this The quarter. large portion (84%) of support from Other fund sources came from various businesses funding small contracts for locally managed instructional programs<sup>2</sup>

through the College of Business, College of Engineering and Engineering Technology and College of Liberal Arts and Sciences. Most of these contracts are reported to SPA at year-end hence the predominance in funding for fourth quarter reporting.

Funding from the Department of Education (received through the Illinois Board of Higher Education) provided ongoing support (\$90K) for the Illinois Tutoring Initiative in the College of Education.




Figure 6 Note: Other category includes agencies contributing less than 1% of the total.

Most of the funding for Other Sponsored Activities (Figure 6) for this quarter was received from the Illinois Department of Children and Family Services (DCFS), contributing 67% or \$12.1M. This funding represents the outstanding contracts mentioned in the prior SPA report that were still under negotiation between SPA and the agency.

In addition to DCFS, most of the funding from the Department of Education was received by NIU through the Illinois State Board of Education (ISBE) for projects run by the Division of Outreach, Engagement and Regional Development including federally funded migrant education programs (\$570K) and the ISBE data warehouse (\$3.7M). Direct funding from the Department of Education included \$587K for the Precollegiate-Upward Bound program to identify, select, and serve 120 low-income, potential first-generation high school students who lack adequate preparation and need academic support.

The National Endowment for the Humanities/National Foundation on the Arts and the Humanities provided \$349K for the NIU Latinx Oral History Project Digital Collection. This initiative will create a large collection of free-use, online oral histories and transcripts documenting Latinx experiences and history in the Midwest.

#### **Funding Trends Across NIU Colleges and Divisions**

Table 1 presents the relative differences in total funding between FY23 and FY24 for each college/division, highlighting changes in the sponsored funding portfolio across NIU's academic colleges and units. The College of Education saw the most substantial increase at 99%, followed by the College of Business at 49%. The College of Education experienced a significant rise in funding primarily due to three major projects: \$2.5M for delivering sport leadership programming within Illinois Juvenile Facilities through Kinesiology and Physical Education, \$2.1M for creating career pathways that lead to workforce development for rural underserved students in northwest Illinois through the Rural Postsecondary Career and Economic Development grant with Highland Community College and the Regional Office of Education, and \$1.3M for the Illinois Tutoring Initiative. Additionally, the Department of Special and Early Education received \$500K for two projects aimed at increasing the number and improving the quality of personnel fully credentialed as teachers of students with visual impairments (TVIs) or orientation and mobility specialists (OMSs) to serve diverse children. The College of Business experienced a 49% increase due to the instructional courses (namely Executive MBA) delivered during FY24 and mentioned previously in this report under Instructional Programs.

There was a decrease in FY24 funding for Other Academic Units by 79% due to the conclusion of COVID-19 funding including support from the Governor's Emergency Education Relief Fund (GEER); a 51% decrease for the Division of Outreach, Engagement and Regional Development due to a multi-year contract from the Illinois State Board of Education to manage the Illinois Report Card program that was fully reported last fiscal year, and a 47% decrease for the Collee of Visual and Performing Arts due to the completion of one project. The 41% decrease for the College of Engineering and Engineering Technology is primarily due to last year's reporting of the \$1.5M microelectronic lab support secured through Representative Underwood's office as part of the university's Community Development Project Funding program.
